ADVERTISEMENT FOR APPOINTMENT OF VICE CHANCELLOR, INDIA INTERNATIONAL UNIVERSITY OF LEGAL EDUCATION AND RESEARCH, GOA

Nominations/ self-nominations are invited by the Selection Committee for the Post of Vice Chancellor, India International University of Legal Education and Research (I.I.U.L.E.R.), Goa, from eligible persons. The details relating to eligibility and service conditions and the format of the application is available on the University website at www.iiuler.com. ELIGIBILITY AND TERMS & CONDITIONS:

As per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018 and Statute of the Goa Legislature vide Act, India International University of Legal Education and Research of the Bar Council of India Trust at Goa Act, 2021 (Goa Act 16 of 2021 dated 13.8.2021).

A person possessing the highest level of competence, integrity, morals and institutional commitment shall be appointed as Vice-Chancellor.

The person to be appointed as Vice-Chancellor should be a distinguished academician, with a minimum of ten years of experience as a Professor of Law in a University or must be possessing ten years of experience in a reputed research and/or academic-administrative organization with proof of having demonstrated academic leadership in India and abroad. He should have his LL.B. from any reputed University of India; however, LL.M. as well as Ph.D. and Doctoral Degree from a reputed Foreign University shall be preferred.

The Vice-Chancellor must be an academic person and a distinguished scholar in law in a relevant subject, or an eminent jurist. He will be a full-time, salaried officer of the University.


The first Vice-Chancellor shall serve for a term of five years from the date he takes office or until he attains the age of seventy years, whichever is earlier. He is, however, eligible for reappointment for a further term of five years, as well as other terms of five years, until he attains the age of seventy. The Board of Trustees shall make the appointments/re-appointments on the recommendation of the Search-cum-Select Committee and as well as by the Executive Council.

SALARY AND SERVICE CONDITIONS:

The post of Vice-Chancellor carries fixed salary of Rs.2,10,000/- plus Rs.25,000/- allowances (However, the Board may enhance the amount on the recommendation of Search-cum-Selection Committee).

The Vice-Chancellor is expected to stay at the residential accommodation to be provided by IIULER, Goa, and no house rent allowance will be paid in lieu of this. However, until IIULER, Goa provides residential accommodation, he will be paid a fixed H.R.A. of Rs.50,000/- per month. The Vice Chancellor shall be provided with an official car.
